General Manager (Mtls), Assam Gas Company Limited, Duliajan- 786602,Dist.Dibrugarh(Assam) on or before the bid closing date and time as mentioned above. 5. **Validity** : The bid must be valid for 180 days from the date of opening of the bid.

6. **Delivery**:The ordered materials shall have to be delivered at AGCL's Stores, Duliajan within 15 (fifteen) days from the date of receipt of the Purchase Order by Fax/Email etc.

7. **Liquidated Damage** : The completion of delivery of the entire quantities of Materials as mentioned above within the schedule date of completion of delivery shall be deemed to be the essence of the contract. In case of delay in delivery of the materials within the stipulated period, unless such delay is attributable to owner (AGCL) or due to Force Majeure, there will be reduction in contract value @0.5% (point five percent) for undelivered quantities of materials for each week of delay or part thereof subject to maximum of 5% (five percent)of the total contract value as liquidated damage. The Liquidated Damage charge shall be recovered from the supplier's bill invoice.

8.Guarantee/Warrantee: Guarantee/Warrantee shall stand as per Manufacturer warranty Certificate. Warrantee should be survived for minimum 12 months.

9.Documents/Certificates to be submitted: The eligible vendor has to submit Materials Test Certificates along with supply of materials.

10. **Payment:** 100% Payment shall be made to the supplier within 30 (thirty) days after receipt and acceptance of materials against submission of original invoice in triplicate along with all relevant documents as per NIT & P.O.

11. Conditional bids are liable to rejection at the sole discretion of the Company.

12. **Applicability of Law & Jurisdiction** : The Order shall be governed and interpreted in accordance with the applicable laws of India and Dibrugarh Courts in the State of Assam shall have exclusive jurisdiction
