2. The TOTAL AMOUNT shall be in figure as well as in words. No overwriting shall be allowed In case of discrepancy, the rates quoted in words shall be considered to be correct.

3. Sealed envelope containing the bid duly filled in as per above Format on bidders letter head should reach Dy. General Manager (Materials) Assam Gas Company Limited, Duliajan- 786602, Dist.Dibrugarh(Assam) on or before the bid closing date and time as mentioned above. If the bid closing date happens to be holiday /bandh called then the next full working day will considered as bid closing day.

5. **Validity** : The bid must be valid for 90 days from the date of opening of the bid. :2:
6. **Delivery**: The ordered materials shall have to be delivered at AGCL's stores, Duliajan within 30 (Thirty) days from the date of receipt of Purchase Order, by e-mail. FOR other than Duliajan shall not be accepted.
7. **EMD**: The bidder has to submit EMD with respect to total value of supply with reference to the Annexure - 1 in the form of Bank Draft drawn in favour of Assam Gas Company Limited payable at Duliajan. The EMD will be released on completion of supply and acceptance of materials. However in case of item with warranty, EMD shall be released only after successful completion of warranty period. The EMD will be forfeited by the company in case party fails to supply the materials. The EMD of unsuccessful bidders shall be refunded after issue of the Purchase Order to the successful bidders.
8. **Liquidated Damage** : The completion of delivery of the entire quantities of Materials as per P.O. within the schedule date of completion of delivery shall be deemed to be the essence of the contract. In case of delay in delivery of the materials within the stipulated period, unless such delay is attributable to owner (AGCL) or due to Force Majeure, there will be reduction in contract value @0.5% (point five percent) for undelivered materials for each week of delay or part thereof subject to maximum of 5% (five percent) of the total contract value as liquidated damage. The Liquidated Damage charge shall be recovered from the supplier's bill invoice. The date of delivery period shall be calculated from the date of issue of LR copy for calculation of LD clause.
9. **Warrantee**: For item SI No 4, SI No 5 & SI No 6 of Annexure-II of the NIT, warranty from manufacturers for one year from the date of receipt of the items is to be provided. For other items no warranty certificate is required.
10. **Dispatch**: The materials shall be dispatched by suppliers own arrangement with risk and responsibility. The materials should be delivered at Duliajan with all precautionary measures for protection from damage during transportation. The materials should be insured against any loss or damage, theft etc. during transit period. The transit insurance is in supplier's scope.
11. **Certificate**: Following Certificate are to be submitted along with delivery of materials .
i) Calibration Certificates for item SI no. 1 & 2
ii) Test & Calibration Certificates for item SI no. 3,4,5 & 6
12. **Payment**: After complete delivery of ordered materials & acceptance of the same, AGCL shall try to release payment within 30 (Thirty) days subject to submission of invoice in triplicate along with all relevant documents as per the NIT and the P.O. No advance payments is admissible. The bidder should submit following documents for release of payment.
i) Original invoice in triplicate, ii) Warranty Certificate issued by manufacturer's iii) Test & Calibration Certificate iv) Transit insurance copy. iv) Delivery Challan etc.
13. Conditional bids are liable to rejection at the sole discretion of the Company.
14. **Applicability of Law & Jurisdiction** : The Order shall be governed and interpreted in accordance with the applicable laws of India and Dibrugarh Courts in the State of Assam shall have exclusive jurisdiction
