5. The Sealed envelope containing the bid shall be marked at the top of the envelope with the following

6. The company will not be responsible for any postal delay or non-receipt.
7. **Validity** : The bid must be valid for 90 days from the date of opening of the bid.
8. **Delivery** : The ordered materials shall have to be delivered at AGCL's stores, Duliajan within 30 days from the date of receipt of the Purchase Order . No part delivery will be accepted.
9. **Guarantee/Warranty**: The materials supplied by you should be free from all manufacturing/workmanship defects. If any defect is found during inspection and use, the same should be replaced by you at free of cost and freight. The bidder has to submit all the test certificate to ensure quality of the materials.
10. **EMD**: The bidder has to submit EMD with respect to total value of supply with reference to the Annexure – I in the form of Bank Draft drawn in favour of Assam Gas Company Limited payable at Duliajan. The EMD will be released on completion of complete delivery and acceptance of materials. The EMD will be forfeited by the company in case party fails to supply the materials. The EMD of unsuccessful bidders shall be refunded after issue of the Purchase Order to the successful bidders.
11. **Liquidated Damage** : The completion of delivery of the entire quantities of Materials as mentioned above within the schedule date of completion of delivery shall be deemed to be the essence of the contract. In case of delay in delivery of the materials within the stipulated period, unless such delay is attributable to owner (AGCL) or due to Force Majeure, there will be reduction in contract value @0.5% (point five percent) for undelivered quantities of materials for each week of delay or part thereof subject to maximum of 5% (five percent) of the total contract value as liquidated damage. The Liquidated Damage charge shall be recovered from the supplier's bill invoice.
12. **Payment** : 100% Payment shall be made to the supplier within 30 (thirty) days on receipt of technically correct bill in triplicate subject to receipt and acceptance of all materials at stores.
13. Conditional bids are liable to rejection at the sole discretion of the Company.
14. **Applicability of Law & Jurisdiction** : The Order shall be governed and interpreted in accordance with the applicable laws of India and Dibrugarh Courts in the State of Assam shall have exclusive jurisdiction
