7. **Validity:** The bid must be valid for 90( Ninety) days from the date opening of the bid.

8. **Delivery:** The ordered materials shall have to be delivered at AGCL's stores, Duliajan. within 30 ( thirty ) days from the date of receipt of Purchase order by Email etc.

9. **Certificate to be submitted:**

The eligible vendor shall have to submit certificates as per technical specification of the items given in SL No.1 of the tender from concerned authorities in support of standards followed and approval required for manufacture of the items.

10. **Liquidated Damage:** The completion of delivery of the entire quantities as mentioned above within the scheduled date of completion of delivery as per Clause-8 above shall be deemed to be the essence of the contract. In case of delay in delivery of the materials within the stipulated period, unless such delay is attributable to owner ( AGCL) or due to Force Majeure, there will be deduction on contract value @ 0.5% ( point five percent) Per week as Liquidated Damage for undelivered quantities of materials for each week of delay or part thereof subject to maximum of 5% ( five percent ) of the total contract value, as liquidated damage. The Liquidated Damage charge shall be recovered from the supplier's Bill invoice. The date of issue of lorry receipt shall be considered as date of delivery for calculation of L.D. amount.

11. **Payment:** AGCL shall try to release 100% (Hundred Percent) payment within 30 (thirty) days after receipt and acceptance of materials against submission of original invoice in triplicate along with all relevant documents as per Purchase Order and the NIT. No advance payment is admissible.
