1. The bidder must be original manufacturer or authorized dealer/ reseller of Gen Set Parts. The bidder has to submit authorization certificate from manufacturer or its area representative with up to date validity.
2. The bidder should quote their rates with maximum discount on MRP as per the FORMAT given below. The manufacturers' price list must be enclosed along with bid offer.

3. The TOTAL AMOUNT shall be in figure as well as in words. No overwriting shall be allowed. In case of discrepancy, the rates quoted in words shall be considered to be correct.
4. Sealed envelope containing the bid duly filled in as per above Format on bidder's letter head should reach Dy. General Manager (Materials)-HOD, Assam Gas Company Limited, Duliajan-786602, Dist. Dibrugarh (Assam) on or before the bid closing date and time as mentioned above. If the bid closing date happens to be holiday/bandh call then the next working day will be considered as bid closing date. In case next working day is Saturday, the bid closing date shall be Monday.

5. The Sealed envelope containing the bid shall be marked at the top of the envelope with following details:-
 - a. AGCL Tender No.
 - b. Bid closing date.
 - c. Bidder's Name.
 - d. Brief description of supply.


The bid received without mention of above on the envelope shall not be accepted.

6. Bid received vide E-Mail/Fax/Telegram/Telex/Cable/ bid in open condition will not be accepted
7. **Validity:** The bid must be valid for 180 (One Hundred and Eighty) days from the date of opening of the bid.
8. **Delivery:** The delivery of the materials must be completed within 30 (Thirty) days from the date of receipt of the Purchase Order by Email.
9. **EMD:** The bidder has to submit EMD with respect to the total value of supply as in Annexure - I in the form of Bank Draft drawn in favour of Assam Gas Company Limited payable at Duliajan. The EMD will be released on completion of warranty period only. The EMD will be forfeited by the company in case party fails to comply with the terms of the contract. The EMD of unsuccessful bidders shall be refunded after issue of the Purchase Order to the successful bidders.
10. **GUARANTEE/WARRANTY:** Guarantee/Warrantee of the materials shall stand as per Manufacturer Certificate. Guarantee/Warrantee should be for a minimum period of 12 (Twelve) months from the date of supply and acceptance of materials by AGCL or standard manufacturer warranty on the products whichever is higher. The bidder has to submit MTC in support of the products as per standards. For any defects during warranty period, free replacement is to be done.
11. **Liquidated Damage:** The completion of delivery of the ordered item as mentioned above within the schedule date of completion of delivery shall be deemed to be the essence of the contract. In case of delay in delivery of the materials within the stipulated period, unless such delay is attributable to owner (AGCL) or due to Force Majeure, there will be reduction in contract value @ 0.5% (Point Five Percent) per week for undelivered quantities of materials for each week of delay or part thereof subject to maximum of 5% of the total contract value, as liquidated damage. The Liquidated Damage charge shall be recovered from the supplier's bill / invoice. Delivery period shall be calculated from the date of dispatch of the items.
12. **Payment :** 100% (Hundred Percent) payment shall be made to the supplier within 30 (thirty) days after receipt and acceptance of materials against submission of original invoice in triplicate along with all relevant documents as per P.O. and the NIT. Payment will be done through RTGS only. So, requested to provide the following Bank details :
 - a) Bank Name
 - b) Branch Name
 - c) Account Number
 - d) IFSC Code
13. Conditional bids are liable to rejection at the sole discretion of the Company.
14. **Applicability of Law & Jurisdiction:** The Order shall be governed and interpreted in accordance with the applicable laws of India and Dibrugarh Courts in the State of Assam shall have exclusive jurisdiction.

15. The Company reserves the right of rejecting any or all bids accepting any bid in part, without assigning any reason.
